Candidate Information and Confidentiality

- 6. We maintain Candidate details on our Database. We will contact you from time to time to ensure our records are up to date and, if requested, will update you with relevant market developments and opportunities
- 7. We will not disclose candidate identity to a client without agreement and information is not shared with any third parties whatsoever unless there is candidate authority
- 8. We consider ourselves to have acted for a candidate at and after the point when we present their details to a client. When this occurs, we are required to keep records for a minimum of one year
- 9. The candidate understands that Client Organisations often disclose information during a selection process that is confidential (or we may do so on the client's behalf): Any information received by the candidate should be treated as confidential unless this is known to be in the public domain

Candidate Accountability
